General Terms of Sales Conect Business Forum 2023

Article 1: Registration Conditions

All professionals applying for registration recognize that they exercise their skills in accordance with the regulations in force (diploma required, registration with an order or a professional register, etc.). The organizer reserves the right to request any supporting document before accepting the registration application.

Registration is open until <u>September 30th</u>, <u>2023</u> inclusive. The registration to the forum requires the completion of an application form.

The registration of a participant can be done with a personalized schedule of scheduled appointments that allow him to meet companies who have requested an appointment with or without a personalized schedule.

The registration becomes final only after payment of the total price of the registration. Validated entries constitute a firm commitment to participation. They give rise to the dispatch by **CONECT International**, after reception of the payment of the price of the inscription, of the access codes to the contact named by the company.

A motivated email is sent to companies or organizations whose application cannot be considered.

Upon registration, the participant will send the payment in order to **CONECT International** or will give the representative of **CONECT International**, a check of the total amount inclusive of the service ordered or proof of bank transfer. Upon receipt, an invoice of the total amount will be sent to the participant. In the event of non-compliance with the deadlines for settlement, **CONECT International** reserves the right to cancel the registration and to blame the company for this.

Article 2: Benefits

As part of this forum, the participation fees paid by the company include the services included in the file entitled "Village Exhibitors CONECT BUSINESS FORUM 2023". The services not included in the package will be the responsibility of the participant and paid directly by the latter to its provider, without that CONECT International is in solidarity with the debt contracted by the participant.

Article 3: Commitment

a) Commitment to the Forum:

The exhibitor undertakes to fill directly online on the CBF 2023 Platform a descriptive technical sheet of his company and detailing his services. CONECT International reserves the right to cancel the participation of a company and to blame it, if it does not fulfill, within the time limits, the elements necessary for the good purpose of the service that it is committed to provide. During the forum, the exhibitor undertakes to honor the appointments of the participants who have expressed the wish to meet him. A participant may be replaced by a person not yet registered until September 30th, 2023, provided that he informs CONECT International, by sending him the surname, first name and function of his substitute. CONECT International cannot be held responsible for incomplete and / or erroneous information published in the catalog CONECT BUSINESS FORUM 2023. CONECT International reserves the right to refuse the participation of a company if its size and the object of its activity do not fit the purpose of the CBF 2023 Forum. In any case, CONECT International is not liable for the costs incurred by the participant.

b) Use of the Internet access during the Forum:

By using the Internet access made available during CONECT BUSINESS FORUM 2023, the participant is prohibited from transmitting or downloading any prohibited, illegal, contrary to morality or public order information that is harmful to or likely to undermine rights of third parties and in particular intellectual, literary, artistic or photographic rights. It prohibits any fraudulent, abusive or excessive use that could disrupt the availability of the internet service. Furthermore, CONECT International cannot be held responsible for any damage that may result from the use of this internet access or disturbances or interruptions of this service.

c) Civil liability of participants:

Each participant agrees to check with his insurance company the extent of his civil liability during the duration of the Forum.





d) Communication – Right of publicity:

For the communication needs of the CBF 2023 forum, each participant expressly agrees to be filmed and / or photographed during the forum and authorizes the dissemination of the images thus taken, in any paper or digital format and on social networks, in Tunisia and abroad, chosen by the CONECT International or a partner of the event. The shooting by the participants is possible, but their use for commercial purposes is strictly prohibited. In addition, participants must respect the image rights of each person.

e) Data Protection Act:

Participation in the forum involves the collection and computer processing of personal data.

In accordance with the provisions of the law, participants benefit from a right of access to information which concerns them as well as a right of rectification and deletion which they can exercise with CONECT International.

f) Follow-up of the Forum:

The exhibitor undertakes to inform CONECT International of the contracts that may be concluded as a result of this operation, by answering the evaluation questionnaire which will be given to him at the end of the Forum.

Article 4: Responsibility

The organizer cannot under any circumstances be held liable by:

- The presence or absence at the forum of a participant and / or the conduct of appointments between participants.

The appointments are chosen by each participant who agrees to participate voluntarily. They are driven under his sole and entire responsibility. The organizer does not guarantee the participants any results or business opportunities following the holding of the forum.

- Cancellation or interruption at any time by a participant of an appointment. No compensation, in any capacity whatsoever, can be claimed from the organizer due to the lack of holding or the partial holding of an appointment.
- Content of information and comments exchanged between participants during the forum, especially during appointments. Participants undertake to strictly respect business secrecy. The organizer cannot be sued for any reason whatsoever for non-compliance by one of the participants with the obligation of confidentiality to which he is bound.
- The organizer does not have to intervene in disputes that may arise between the participants and can in no way be held responsible for any consequences that may result.

Article 5: Force Majeure

If the forum cannot take place due to force majeure or decision of the competent authorities for security or safety reasons, no compensation will be paid by the organizer to registered companies.

Article 6: Terms of Cancelation

• In view of logistical requirements, companies registered and validated by the head of delegation may not cancel their registration after September 30, 2023.

By "registered company" we mean: Companies having paid 100% of their registration via their head of delegation, registered online and validated by the head of delegation before September 30, 2023.

• Force majeure:

Any withdrawal due to force majeure must be communicated by the participating company (or the head of delegation) by email.

The letter must contain the reasons for the withdrawal and the corresponding (original) supporting documents.

Are considered in particular as force majeure: illness, accident, death of a close relative, natural disasters.

NB: Refusals to issue visas are not considered force majeure.





It is up to each participant to take the necessary measures to submit their visa application on time and to obtain their visa before September 30, 2023.

Any withdrawal in the event of force majeure must be communicated to the organizer. For the withdrawal communicated after September 30, 2023 and the reimbursement will entail file processing costs which will be borne by the participant at the rate of 300 euros per exhibitor.

Article 7: Applicable Law – Competent law courts

The present regulation is subjected to Tunisian law. Any disputes arising from the validity, interpretation, performance or non-fulfillment of these general conditions of sale, will be subject to Tunisian law.
